MASSACHUSETTS MUST PASS A LAW THAT EXTENDS THE STATUTE OF LIMITATIONS IN DOMESTIC VIOLENCE CASES.

Statute of limitation laws establish the window of time to prosecute an alleged perpetrator of a crime and vary by state. The current statute of limitation for domestic violence crimes in Massachusetts is six years, meaning that the victim of domestic violence must report their abuse and pursue a lawsuit within six years of the crime or the opportunity is forever lost.

A U.S. Department of Justice Special Report states that victims generally do not report their initial intimate partner victimization, and typically suffer multiple assaults or related victimizations before they contact any authority. Many survivors fear for their lives due to threats and coercion from their perpetrators, and it can be years before a victim feels safe enough to come forward. Additionally, while numerous victims with PTSD develop symptoms within three months of their trauma, many will not notice symptoms until years after, when many survivors can no longer seek justice.

This legislation, known as the Phoenix Act, originated in California and became law in 2020, with many more states following suit. In addition to extending the statute of limitations for domestic violence cases from six to fifteen years, it also adds "technological abuse" (abusive behavior occurring via the Internet and other forms of technology) as well as "coercive control" (intimidating or humiliating behavior designed to further the imbalance of power within the relationship) to M.G.L. Ch. 209A.
